- ____ 1. All twirlers participating in the Spirit Spectacular must attend the 5 **mandatory** rehearsals listed below. Practices are held at *Our Lady of Grace School, 1990 Linden Rd, West Sacramento, CA 95691*
 - ✓ *Sunday, April 7th* (Mandatory new parent meeting while students practice)
 - ✓ *Sunday, April 14th*
 - ✓ *Sunday, May 5th*
 - ✓ *Sunday, May 19th*
 - ✓ *Sunday, June 2nd* (Last practice & Dress rehearsal)

- ____ 2. Age groups will be assigned 1 hour practice time slots once we receive all signed contracts. **All participants must be available to practice on the above mentioned dates between the hours of 1:30 and 5:30PM.** Failure to comply with these commitments will preclude participation, and will further result in forfeiture of all performance fees. There will be no refunds due to poor attendance.

- ____ 3. Recreational twirlers participating in the Disneyland Spectacular production are required to attend their normally scheduled baton classes at school. It is vital to the entire team, for all twirlers of all ages, to have respectable attendance.

- ____ 4. A working email address must be in place. This is our main form of communication. Be sure **office@csmbaton.com** is added to your contacts. Missed information that has been emailed is not a legitimate excuse and may cause any/all of the above rules to be enforced and subsequently cause the twirler to be dismissed.

- ____ 5. All first time Disney performer parents are required to attend the parent informational meeting at the beginning of the first practice on April 7th.
